Remarks

1. WP1 1.2 Study visits to program countries; Current travelling restrictions across partner and program countries;
FHJ and DHBW will give a proposal for study visit in October. There will be one study visit organized in October 2021.
2. Financial reporting related to study visits
Prof. Savic gave the instructions about the reporting related to study visit in Subotica. The templates and instructions will be sent to the partners after the meeting in Subotica.
3. WP 1.3 Report on survey on companies regarding dual education WP leader: WUS
The representative of WUS gave the report about survey on companies in BIH.
There is a possibility of publishing the report or part of it in scientific journal.
4. WP 2.2 Organization of Conference on DUALSCI added value on industrial sector
The conference will be organized by UES in Bjeljina, in October 2021.

2.3 Discussion Forum on the proposed DUALSCI model with key stakeholders and policy makers will be organized by BIT alliance, with cooperation of two chambers of commerce, in November 2021. in Sarajevo.

Prof. Petkovic suggested Technological park in Mostar as possible place of meetings with stakeholders in the future.
5. WP3 Presentations of legal framework on dual education
UES: Preparation of ammendment by the end of the year
UNZE: Several meetings, meeting with new representative from the ministry. Time frame: In the ministry there is no person for HE at the moment.
UNSA: On June 3rd the draft law was introduced. Public discussion will last for 60 days. In September the law will be accepted. University will do by laws.
SUM: According to current Law on higher education, and after the approval of respected ministry, dual education is introduced into legal framework.
6. WP 3.4 Organization of Discussion forum on draft proposals of ammendments
The forum will be organized by the end of January in 2022.
7. WP 4.2 Organization of Presentation of specific dual models of HEIs to companies
UES already has done several meetings with companies. They will help other partners to organize meetings by February 2022.
