### Remarks

1. Financial reporting related to staff costs  
Coordinator has informed the partners about the deadline for spending more than 70% of received budget. The partners were advised to submit the travelling reports from Graz as soon as possible and to send reports about staff costs for the first half of the project.
2. Statistics of study programs  
Nenad Marković from UES will be in charge of collecting the statistics about study programs.
3. WP 4.4 Plan for pilot testing of the specific dual of HEIs (by the beginning 2022)  
The partners are reminded to develop the plan for pilot testing by the beginning of 2022.
4. WP1 1.2 Study visits to program countries; Current travelling restrictions across partner and program countries;  
The proposal is to organize a study visit to IMH in March 2022 and to DHBW in May 2022.

By February 2022 the draft agreements will be developed. DHBW will send their examples to BH partners, while UNS sent the templates from DUALEDU and DIARKAZ projects in July 2021.
